## HOW TO USE THIS PACK

*Campers & Their Parents* : Give them a copy of the **Camper Registration Blank**, **Parent Letter**, **What To Expect sheet**, and the **Combined Release Form**. The release form **MUST** be signed by their parent/guardian.

*Adult Volunteers/Staff* : Give them the **Volunteer/Staff Application**, **Volunteer/Staff Info sheet** and **Volunteer/Staff Commitment Form** in addition to the **Combined Release Form** and the **What To Expect sheet**.

Please don't mail us the paper registration forms, we can't process those. Please retain the originals of the Volunteer/Staff Applications, though. You'll complete your group's registration online at [campvineyard.com/register](http://campvineyard.com/register)

## SUBMITTING RELEASE FORMS ONLINE

You can submit scans/photos of completed release forms, Volunteer Commitment, and Early Pick-up forms online. **WE CANNOT ACCEPT TYPED "SIGNATURES" ON THESE FORMS**. Also, please don't upload a copy of this entire pack for each participant or upload your entire group's forms under one participant. We suggest bringing the paper versions in a folder as a backup, just in case. Incomplete/incorrect forms will slow down check-in.

## MAKING CHECK-IN GO QUICKLY AT CAMP

Before you leave the van/bus, collect all electronics from your Campers. We'll inventory, bag, and label your entire group's collection at one of the check-in stations. Hand out the following:

**For every Camper:** Completed COMBINED Release form (if not submitted online), their bag of prescription meds, and their Early Pick-Up form if they have one.

**For every adult:** Completed COMBINED Release form, Vol. Commitment forms (if not submitted online), bag of meds.

If you submitted forms online, then you have a lot less to do! Being sure the releases are completed correctly and submitted online will make your first 30 minutes at Camp so, so much easier! We believe that Camp Vineyard exists to call out the future church planters, pastors, volunteers, and leaders of the Vineyard, encouraging them to seek an active relationship with Jesus in the fullness of the Holy Spirit. And your involvement before and after Camp is a key part in helping us do just that!

## CAMPER CODE OF CONDUCT

### **Always respect other Campers' physical boundaries:**

- No guys are allowed in the girls' cabins or cabin areas, and no girls are allowed in the guys' cabins or cabin areas
- No kissing, "making out", or intimate touching
- No sharing of shower or bathroom stalls
- Everyone sleeps in his/her own bed
- No hitting, kicking, slapping, or punching
- No touching of private areas of the body (including slapping someone on the rear)
- No physically demeaning humor (wedgies, etc.)
- No walking around cabin or shower areas without covering private areas of the body.

### **Always use appropriate communication**

- Tell the truth
- Be clear
- Don't be a gossip
- No profane, "locker room", or "bathroom" language

### **The following behaviors have no place at Camp:**

- Use or possession of alcohol, tobacco, or any illicit drugs
- Any sexual behavior
- Stealing or lying
- Profanity or other inappropriate language or conversation
- Disrespectful attitudes
- Skipping events
- Abuse of any form
- Bullying
- Gossip

Any display of the above behaviors will be addressed respectfully, but firmly, out of care and concern for the well-being of all Campers. See the summary of the Disciplinary Policy below.

### **Our Volunteer/Staff are given the same Code of Conduct, though the following are specific to them:**

- No Camper is ever to be taken off by themselves, out of sight of a public setting.
- Do not give gifts of a personal nature to Campers
- Do not show favoritism to a particular Camper
- One-on-One counseling or private conversation is always to be done in a public setting where they can be seen, though not necessarily heard
- Hold other staff accountable

## CAMPER'S RIGHTS

- To have privacy when in private areas (Bathroom, shower, cabins)
- To tell someone when they're feeling uneasy about ANY situation
- To be treated with respect
- To be taken seriously

## DISCIPLINARY POLICY SUMMARY

All disciplinary situations are to be handled by the Deans. Deans are pastors and their spouses, who each have years of experience in ministry and have been selected to act as support to our volunteer Counselors and caretakers for our Campers. The Deans are overseen by the Site Pastor, who works in conjunction with the Site Director. In no circumstance is corporal punishment allowed. In a disciplinary situation, the Deans are to:

1. Remove the individual from the situation, following above guidelines for one-on-ones.
2. Communicate care, love, and concern for them.
3. Define the inappropriate behavior without attacking their character.
4. Communicate lack of tolerance for the behavior, explain the reasoning.
5. Partner with them in helping them change the behavior.
6. Seek the root of the problem.
7. Administer consequences with the help of the Site Pastor or Site Director. These can include removal from activities for a period, personal apologies to those affected, temporary assignment to help with activities around the Camp, or even dismissal from Camp. ***Again, corporal punishment is not allowed in any circumstance.***
8. Spend time extending grace and forgiveness, and work to restore the relationship.

We do reserve the right to dismiss Campers and volunteers from the program in extreme situations, as a last resort. In the unlikely event that becomes necessary, we will work with you and your group's leader to make arrangements.

## WHAT TO EXPECT

There's going to be a lot more to Camp Vineyard than S'mores and awesome games. Oh, sure, we'll have those too; but we've got some other great stuff happening, and we want you to be prepared.

## GUIDELINES

### Clothing

We understand the weather in Georgia is hot. Still, we're big on creating an environment that's appropriate and fosters mutual respect for all attendees. Here are things to keep in mind while choosing your clothes:

- Attendees must remain fully clothed (tops and bottoms). Dudes, we're not playing "Shirts v. Skins" Ultimate Quidditch.
- T-shirts/coverups must be worn when going between the Cabin and the Bathhouse or Pool.
- Swimwear must be worn for swimming. Swim bottoms must have full coverage (no speedos), and swim tops must also cover midsection (no bikinis).
- "No Buttons, No Cheeks" – Pair cropped shirts with shorts/pants that cover your midsection and choose shorts that provide coverage so the only cheeks anyone sees are the ones attached to your face.
- Athletic shirts with air vents/split seams should not expose large portions of skin.
- Sleepwear should only be worn in cabin areas. Camp is not Walmart, and those bunny slippers are going to be nasty after a trip to Big Game and back.
- Undergarments must always be covered and cannot be worn alone in public.

All the above applies equally to all attendees. Anybody not meeting these standards may be asked to change. If you're not sure about an outfit, ask the Dean of your cabin area at Camp.

### Medication

We are aware that many Campers need medication and special accommodations due to health issues. Our on-site volunteer medical staff work hard to help meet these needs safely. However, there are a few things they need your help with as you know your Camper best.

- Prescription medications and their schedule need to be updated **every year** on the registration form and will be given to medical staff during check-in.
- Medications must be in a prescription bottle with Camper's current, legible, in-date prescription.
- If medication needs to be given at specific times, this needs to be clearly stated. Otherwise, the medication will be administered at designated mealtimes (breakfast/AM, lunch, dinner/PM) and at bedtime.
- Emergency medications (inhalers, epi-pens, etc.) need to have the Camper's name clearly written on it. We request a **written, signed** consent be attached stating your wish for medical staff or your Camper to hold. If your Camper is designated, they must be responsible enough to always have it on their person.

- Certain medications (allergy, OTC, etc.) may be left with the Camper at the medical staff's discretion due to influx of medication needs.
- If corrective or supportive devices (i.e., knee braces, arch inserts, etc.) are to be worn, the Camper must bring these with them. Camp is very active, and your Camper will need to be prepared.

### Things NOT to Bring

- Your dad's old iPod, your mom's old Walkman, or that cool record player you got for Christmas.
- Tablets, portable video games, media players, other electronics.
- Weapons or drugs. See above for info on prescription medications.
- Our medical staff will have common OTC meds like aspirin, Tylenol, Advil, indigestion, and OTC allergy medications on hand, you won't need to pack them. If you have an OTC medication you think is unusual, that's OK to pack.
- **Nuts or snacks containing nuts of any kind.**

### What about Phones, Tablets, or other Devices?

At check-in, we will collect and label all Camper cell phones as well as tablets and any other devices. Those will be kept securely with the rest of the devices from their group and returned to their group's leader at the end of Camp.

Camp is about getting away from distractions, taking a break from the constant pull of our devices. It's a time to decompress and focus.

Still, if a need arises, we want to be sure parents can get in touch with their Campers (and vice versa) if something comes up. We encourage parents to get their group leader's cell phone number. **Also, you can call Camp Vineyard at 423.458.2386.** That's a Google Voice number, so if you don't catch one of the team live, we will get your message and address it appropriately.

Of course, if your Camper needs to get in touch with you for something important, we'll be sure they get their phone, or can use another phone. If you have any questions, you can call us at that number above.

## ACTIVITIES

You won't need any weird equipment for the Color Team Competitions and other games, just be ready to win some points for your team. And, if you're a Senior Camper don't forget to choose your Track for the week. You can see all the options at [campvineyard.com/tracks](http://campvineyard.com/tracks). Junior Campers, you're already signed up for Activity Track!

In addition to all the scheduled activities and games, your free time options include basketball, campfires, hiking, slip-n-slide, swimming pool, volleyball, and human foosball, to list a few.

## WHAT TO BRING

### **Packing List** (*Put your name on your stuff!*)

- Clothes for each day. Be sure to bring extra clothes, including ones you don't mind getting messy in.
- Pajamas
- Sandals
- Tennis shoes (certain activities require closed toe shoes)
- Shower shoes
- Toiletries (Especially deodorant.)
- Towels and washcloths
- Swim towel
- Sunscreen
- Linens (twin bed) or sleeping bag
- Pillow
- Cash for Canteen, Camp Store, etc.
- Bible & Notebook
- Pens or pencils
- **Prescription medication: Refer to medication guidelines for more details.**
- Camera not attached to your smartphone or other device
- Flashlight
- Sunglasses
- Hat
- Bug Spray
- Bag for dirty clothes
- Reuseable water bottle
- Backpack
- Snacks (**All snacks must be nut-free.**)
- Football, Frisbee, soccer ball, baseball and glove, etc.
- USB Power Bank (only if your leader lets you use devices on the drive home!)

## VOLUNTEERS AND GROUP LEADERS

If you're an adult volunteer and it's your first time at Camp, here are a few extra things you and your group should add to the list, courtesy of some Camp Vineyard vets (for things listed as "1 per cabin" figure 1 for every 8-10 people in your group):

- Bottled water
- Electrolyte drinks
- Salty snacks & sweet snacks (**no nuts**)
- Spray deodorant
- Scented dryer sheets (Place under bunks, on air conditioning unit, and in dirty clothes bags)
- Digital clock & batteries (1 per cabin)
- Power strips (1-2 per cabin)
- Febreze (to reduce smells)
- Odor absorbing trash bags (for dirty clothes)
- Clothesline (rope and clothes pins for wet towels, etc.) (1 per cabin)
- Sunscreen
- Bug spray
- Box fan (1 per cabin)
- Ziplock bags for opened snacks
- Paper towels
- Protein shakes (for Campers not eating - Teenagers will Teenager sometimes.)
- Football, frisbee, cards, or other games.

## CAMP VINEYARD WAIVER, RELEASE, AND INDEMNITY

This Waiver and Release (hereinafter "Waiver") must be signed by every adult and youth Participant, and by a parent or legal guardian for every Participant under eighteen (18) years of age, desiring to participate in the Camp Vineyard event sponsored by Restoration Vineyard Church. (hereinafter "Vineyard"), a religious non-profit corporation. Only the Participant named in this Waiver will be allowed to participate in the activities described below, and said Participant will be allowed to do so only upon receipt of a fully executed copy of this Waiver.

The Participant named below desires to participate in recreational, educational, spiritual, sporting, camping, and other activities (hereinafter collectively "activities") which are sponsored, organized, and/or conducted by Vineyard. Participant understands and accepts the risks involved in participating in the activities, and further understands and accepts that participating in the activities involves the possible risk of injury to himself/herself associated with participating in the activities, said risks including, but not limited to, property damage, bodily injury, and even death. Accordingly, Participant assumes all risks of injury to his/her person and property while engaged in the activities, and hereby forever releases and discharges Vineyard, its officers, directors, employees, agents, and representatives, from any and all claims and causes of action, of every kind and description, as well as all obligations and financial responsibility, of every kind and description, resulting from, or arising out of, any incident, injury, or accident occurring while Participant attends or participates in all such activities. Additionally, Participant agrees to indemnify and hold harmless Vineyard, its officers, directors, employees, agents, and representatives, from and against any and all claims and demands, of every kind and description, including, but not limited to, all financial responsibility, liability, and attorney's fees and expenses incurred by Vineyard, its officers, directors, employees, agents, and representatives, as a result of any incident, injury, or accident involving Participant, unless said injury is the direct result of intentional or willful misconduct of Vineyard.

Also, Participant agrees to cooperate with those in charge of the activities at all times, and further agrees to follow any guidelines set forth by Vineyard for said activities. Participant further understands and acknowledges that this Waiver, Release, and Indemnity is intended by Participant to be as broad and all-encompassing as permitted by the laws of the State of Tennessee, and that if any portion of this Waiver, Release, and Indemnity is held to be invalid, then Participant hereby understands and acknowledges that the remainder of this Waiver, Release, and Indemnity shall remain in full force and effect, notwithstanding any such validity.

The Participant named below hereby grants permission to Vineyard medical personnel to order routine medical tests for Participant, including, but not limited to, x-rays and other diagnostic tests, for treatment of Participant's health while Participant is at Camp Vineyard. In the event Participant, for any reason, is unable to assent to medical treatment while a Participant at Camp Vineyard, then Participant hereby grants permission to all attending Vineyard medical personnel to secure proper medical treatment for Participant, including, but not limited to, hospitalization, and to order medical procedures and treatment for Participant as deemed necessary by Vineyard medical personnel, including medical procedures which, in the opinion of any attending physician, may endanger Participant's life, cause disfigurement, physical impairment, or undue discomfort if delayed, including transportation to and from the event site, while Participant is participating in the activities.

Additionally, Participant understands that photographs and/or video, or sound recordings of Participant may be made during the Camp Vineyard event, and Participant hereby authorizes the use of such material by Vineyard for promotional or ministry-related purposes.

### Woodland Camp On-Site Participant Individual Release

As you understand, these activities have inherent and unpredictable dangers that no amount of care, caution, instruction, or expertise can eliminate. Upon recognition of the nature of the activities involved, their inherent risk, and for the opportunity to voluntarily participate in these activities, by signature below, you waive, release and discharge Woodland Christian Camp, Inc., and its directors, officers, employees, volunteers, representatives, and agents from liability. You covenant with them that you will never institute any action at law or in equity for any personal injuries, or injuries to property, real or personal, caused by, or arising out of this trip. You further agree to indemnify and hold Woodland Christian Camp harmless against any and all costs, damages, and expenses which may be incurred by them as a result of any lawsuit you (or your agents) or any other might file against them or arising from your participation in activities at Woodland Christian Camp. We may provide you with written guidelines and verbal instructions for participation in activities. While participating, you agree to follow such guidelines and instructions designed to minimize risk of harm. You grant permission to medical personnel to order X-rays, routine tests, and treatment for your health, and in the event you are unable to assent during an emergency, you hereby give permission to the attending medical personnel to hospitalize, secure proper treatment and to order medical procedures and treatment as deemed necessary. Photographs and/or video and sound recordings of you may be made during your time at Woodland Christian Camp. You authorize the use of such material by Woodland Christian Camp for its purposes. We trust you will safely enjoy your time at Woodland Christian Camp and the activities in which you participate. Please attest to your agreement to the terms of the Release and Participation Agreement by signature below. You also agree to abide by the rules, policies and regulations promulgated by Woodland Christian Camp, Inc. throughout your visit.

**Also, I hereby grant permission to Vineyard medical personnel and any qualified and licensed medical professional to order routine medical tests for my Youth, including, but not limited to, x-rays and other diagnostic tests, for treatment of my Youth's health while they are a Participant in Camp Vineyard.** In the event that my Youth, for any reason, is unable to assent to medical treatment while a Participant at Camp Vineyard, then I hereby grant permission to all attending Vineyard medical personnel to secure proper medical treatment for my Youth, including, but not limited to, hospitalization, and to order medical procedures and treatment for my Youth as deemed necessary by Vineyard medical personnel, including medical procedures which, in the opinion of any attending physician, may endanger my Youth's life, cause disfigurement, physical impairment, or undue discomfort if delayed, including transportation to and from the event site, while my Youth is participating in the activities. However, this authority is granted only after a reasonable attempt has been made to contact me. Additionally, I grant permission to Vineyard medical personnel and any qualified and licensed medical professional to administer medication prescribed by a physician for my Youth, as well as provide routine first aid and over-the-counter medications for treatment. Also, please note that I am reporting any of my Youth's medical allergies, chronic illnesses, or other conditions on the registration form I am submitting.

## *Camp Vineyard Volunteer Info*

Thanks for your interest in being a volunteer at Camp Vineyard! We're glad you want to be a part of our team. Just so we're all on the same page, please read through this entire document. We try to keep things simple, but there are some specific things we want you to be aware of.

### BEFORE CAMP

You'll start the volunteer application process during registration. If you've never served at a Camp Vineyard event before, or it's been a few years, we'll be contacting you for an interview. It's not anything too complicated, but there's a lot that goes on at Camp, with a lot of jobs that need to be done, and we want to be sure we find the best place for you to serve. We want Camp to be a lot of fun for you, too!

Also, we'll require you to complete two pieces of training and a background screening. The first training is our own Counselor World training videos at [campvineyard.com/counselor-world](http://campvineyard.com/counselor-world). These will get you up to speed on our policies, your responsibilities, and the crazy, fun culture we have at Camp. The second training is supplemental child safety training. You'll be emailed a link to their online training, which comes with a test that you'll need to pass to serve. If you were a volunteer last year, we encourage you to take a refresher course on both. You'll receive a separate time-sensitive email to complete a background screening as well.

All of that will take just a couple of hours but will give you the knowledge and tools to be an effective volunteer at Camp. They're easy to do, and we require that you complete these training courses before you can take part in activities at Camp. You'll sign a statement saying that you've completed them, so please take a little time between now and June to do so.

### RESPONSIBILITIES AT CAMP

Every adult at Camp wears multiple hats. It's most likely that you'll be a Counselor, and either assigned to a Color Team or working with Clear Team (those terms are defined below). Wherever you serve, you'll have responsibilities in addition to chaperoning your own church's group.

#### **Counselor**

The Counselor's first job is to ensure Camper safety. We use the term "Counselor" because it's a familiar Camp-related term, however that does not indicate any kind of formal licensure. Counselors, whether in their teams or their cabins, are the first line of care for Campers. A Counselor should be an encourager, cheering on the kids, setting the standard for participation and engagement. Any disciplinary issues should be referred to a Dean. Also, should anything come up during the small group discussions (or any other time at Camp) that requires reporting, this must be done immediately to a Dean, Site Pastor, Site Coordinator, or Site Director. You'll be introduced to all those people at the Opening Session.

Most Counselors will be both a **Cabin Counselor** and a **Color Team Counselor**. Cabin Counselors are responsible for a cabin of Campers from their home church group from curfew at night through arrival at Morning Thing, after breakfast, the next morning.

**Color Teams** are how we split the Campers up for games and other activities. They're made up of students and adults from different churches and will compete together as a team throughout the week. Color Team Counselors' responsibilities for their Color Team begin at Morning Thing and last through to the end of the Main Session, with breaks around meals and Free Time. Counselor World video 3 takes you through a typical day and will answer a lot of the questions you just had reading those last 2 paragraphs.

### **Clear Team**

This is our name for the Staff and any other volunteers who are not part of a Color Team. The Clear Team is made up of the Game Teams, Deans, Nursing staff, Track leaders, and the administrative staff.

### **Dean**

Deans are pastors and/or their spouses selected by the Site Pastor for their years of experience in ministry. Deans are responsible for bed checks in their assigned cabins each night, as well as serving the counselors on their assigned Color Team for discipline, safety, Camper tracking, or pastoral counseling issues. They report to the Site Pastor.

### **Game Team**

A sub-set of the Clear Team that is responsible for the Color Team Competitions, Big Game, or any other large-group game programming. The Game Team will organize and stage the game equipment in Counselor World, set up and run the games at the appropriate locations, and clean up after the games are completed. **Note:** Being a member of the Game Team prevents an individual from being a Color Team Counselor, but not from being a Cabin Counselor.

## NEXT STEPS

If some of those terms sound like Ancient Greek to you right now, that's ok. Remember, you'll need to complete both the Counselor World and supplemental child safety training, and both of those will get you up to speed on everything you need to know before Check-In.
